How will the redistribution of the LIT Expenditure Rate impact Transpo?

It will directly impact Transpo's operating budget by decreasing the support we receive from an important funding source. Transpo will lose 24% of our LIT revenue--a decrease of \$157,979. This unanticipated cut will begin in 2020 and continue every year thereafter.

How much money does Transpo currently receive from LIT?
In 2020, Transpo is projected to receive \$657,720 from LIT. The proposed plan will cut funding to \$499,741 in 2020.

What does Transpo use LIT funds for?
LIT funds are part of Transpo's operating budget.

Why is this change being proposed?
The St. Joseph County Public Safety Communications Consortium (PSAP) adopted a resolution to modify the LIT Expenditure Rate to create a stand-alone income tax rate for the PSAP. For 5 years, the 911 Call Center has been funded by the combined resources of the County, City of South Bend, and City of Mishawaka. The funding agreement between these entities is ending. The new plan will not raise taxes but instead use funds previously allocated to other government units to fund the \$8 million needed for the Call Center. This proposition hurts a number of other local services, including our local libraries.
